
2. Our Deputy Commander of Cluster B, Assistant Commissioner (Ms) Rafidah Bte Suparman had met up with you on 7 Feb and 7 Mar 2019 to address your concerns. Regarding your request to transfer Sallehin to Cluster A, Ms Rafidah had explained that we are unable to accede to your request. The allegation of abuses had also been duly investigated and are not substantiated. Thus, you agreed that the request to meet up with officers, Sallehin and other family members may be futile if Sallehin continues to have differing views from officers on what had happened in prison. With regard to the request for change of diet, Ms Rafidah had informed you that we had facilitated another diet option for Sallehin.

3. In addition, we had also informed you in our letter reply dated 26 Oct 2018 that Sallehin had been seen by the Visiting Justices on 27 Sep 2018. The VJs had no further queries after we had explained to them that the allegations were baseless. As there are no new grounds to your past allegations, we will not be responding to you any further on these issues.

4. Nonetheless, we will arrange for an officer to share with you the background of Sallehin's multiple disciplinary offences in prison. Our officers will also get in touch with you on your request for a medical report. As the medical report is chargeable, we seek your written consent to make payment for this report, after our officers have informed you on the relevant costs.

5. We hope to have your support in helping Sallehin in his rehabilitation in prison. You may contact me at [REDACTED] during office hours, should you need further clarification. Thank you.
