MUHAMMAD NUR SALLEHIN BIN KAMARUZAMAN –

We refer to your representations dated 18 Aug 2020,13 Oct 2020 and 27 Oct 2020 to Ms Mariam Jaafar, Member of Parliament for Sembawang GRC (Woodlands) concerning your son, Muhammad Nur Sallehin Bin Kamaruzaman.

- 2. Further to our initial reply dated 27 Aug 2020, we had conducted an investigation pertaining to the allegations that Sallehin was unfairly treated in Prison. We have established that these allegations are <u>not</u> substantiated and the officer was professional in managing Sallehin. Please be informed that Singapore Prison Service (SPS) takes a serious view towards any groundless accusations made by inmates and hence, Sallehin will be liable to answer to this disciplinary offence.
- 3. We also note this is the 14th time in the last two years that you have written to Singapore Prison Service (SPS) to allege the ill-treatment of your son whilst in our custody. As we have communicated with you previously on the same matter and the allegations had also been duly investigated and not substantiated, please note that this will be our final reply. Going forward, we seek your support in encouraging Sallehin to abide by our regulations and display good conduct and behaviour in prison.
- 4. With regard to his medical appointments, Sallehin went to the Complex Medical Centre in Cluster A on 25 Sep 2020 and 9 Oct 2020 for consultation with the orthopedic specialist and physiotheraphy respectively. Both appointments are scheduled by our Medical Service Provider as part of Sallehin's medical treatment.
- 5. In our earlier reply dated 7 Oct 2020, we had clearly stated that our officers had confiscated the stack of papers from Sallehin during a scheduled search, as they were used inappropriately and without authorization. We have explained the reasons to him and this will be inappropriately and without authorization.



our final reply on this matter. We would also like to clarify that we did not change Sallehin's cell and that he was not involved in any fighting incident last week.

6. SPS is committed to ensure the safe and secure custody of Sallehin, and our officers will continue to discharge their duties professionally.
